Frankincense and Myrrh Supply from East Africa

Frankincense and Myrrh are natural resins collected from trees that are primarily grown in East Africa but also from the Middle East and India and mainly thrive in dry arid climates.

Our Frankincense (Olibanum) comes from the Boswellia Carterii tree (harvested March to July) and Myrrh comes from the Commiphora Myrrha tree (harvested June to October). There are various grades of each of these resins depending upon colour, time of harvesting, size and purity.

These resins have a multitude of uses for incense, fragrances, flavourings, health / beauty and medicinal products. We also produce 100% Frankincense and Myrrh oils through a steam distillation process.

Gargoore is one of the largest exporters of resins and gums in Somalia and has been involved in this business for over four generations. Primary operations in Somalia, Somaliland, Ethiopia and Kenya with trading success globally. 

Our company owned and partner operations are managed very carefully. We guide and monitor all aspects of operations with strict guidelines for tree management, resin / gum and oil production, collection and sorting. All operations are audited throughout the seasons to ensure quality and quantity targets are met and guidelines for codes of practice are adhered to.

Supply partnerships and export contracts are of prime importance to us. We establish and maintain win-win relationships that are fair for all parties involved. We pay our suppliers at the best rate possible for their resins and gums and then we offer reasonable below market pricing for our export clients.

We focus on sustainability in all our operations. Environment, tree and harvest health is maintained through attention to strict guidelines that aim to ensure long term production. This includes compliance of one tapping of each tree per season and limitations to 5 cuts per tree to maintain tree health and quality of product. Regular tree maintenance and replanting is also done to ensure long term production.




How We Work



Resin and Gum production is unlike most agricultural operations. Most of the trees grown for these products thrive in very dry and arid climates and in rocky and mountainous terrains in remote areas. Trees are often scattered throughout a region and grown and harvested by individuals or families who have owned and managed them for generations.

Our extensive network of supplier's work with us on an exclusive basis with some money loaned in advance of harvesting to support the family production. We have a focus on continuous improvement and sustainable operations with all our supply partners.

Gargoore also harvest from trees on ancestral land in Puntiland State of Somalia. They operate sorting and grading centres in Gargore - Puntland, Mugadishu – Somalia, Godey - Ethiopia and Wajir – Kenya. These centres are managed by very experienced staff.



Our Products



FRANKINCENSE

Our Frankincense mainly grows on the Golis Mountains in the Bari region of Somalia. It is collected from Boswellia Carterii trees which grow naturally in Somalia, Kenya and Ethiopia where we also have collection centres. The trees are tapped only once per season and harvest for Frankincense is from March to July.

We produce Frankincense in three grades. Grade one is best quality with larger pure chunks without any tree barks or powder. Grade two vary in size and contain small amount of tree barks and powder. Grade three consists of 100% powder which has been removed during the sorting and grading process.

Frankincense has a wide variety of uses commercially in fragrances / perfumes, incense and aromatherapy (calming effects), flavourings / stabilizers for food and beverage production, skincare (anti-inflammatory and astringent properties, cleansers (anti-bacterial and anti-fungal effects) and medicinal uses (properties for asthma, antiseptics, wound healing, oral health, expectorant, diuretic, digestive, anticancer, sedative and even anti-anxiety and anti-neurotic effects). Traditionally Frankincense has also been widely used in religious ceremonies and other rituals.

MYRRH

Our Myrrh resins are collected from Commiphora Myrrha trees mainly in the Bari region of Somalia. We also source from Somalia Gedo region and Wajir region of Kenya. The trees are taped only once per season and harvest for Myrrh is from March to July.

Like Frankincense our Myrrh has three grades. First grade which is larger size, dark red or pure goldish in colour and without any tree barks or powder. Grade two varies in size and has a small amount of tree bark and powder. The third grade is pure Myrrh powder.



Myrrh also has a variety of uses commercially due to its unique properties for use in fragrances / perfumes, incense and aromatherapy, flavourings for food and beverage production, as a fixative in cosmetics, skin care (eczema treatments, anti-aging with anti-wrinkle effects and reduction of fine lines) and medicinal uses (properties for anti-inflammatory, antiseptic, antibacterial, anti-fungal, antiviral ability in treatments for athlete's foot, oral infections (gingivitis), mouth ulcers, sore throat, wound care, problems in the stomach and intestines, loosening congestion in respiratory system and parasite infections)



FRANKINCENSE & MYRRH OILS

Our 100% Frankincense and Myrrh essential oils are produced in Nairobi, Kenya with a steam distillation process. These oils provide a more concentrated form of the pure Frankincense and Myrrh that then can be used in many different applications without further processing. These oils are more end user friendly and convenient for commercial applications or consumer use.

We are able to provide oils in bulk bottles or custom packaging and labeling according to client specifications. Our team can also work with the client to develop private label branding and packaging to suit their corporate image.

OPOPONAX

Our Opoponax gum comes from the Cammiphora Erythrea tree mainly from the Somali region of Ethiopia. Opoponax is harvested in two seasons and collected from wild cammiphora trees on communal land in the region.

Opoponax gum is naturally sticky and wet therefore it is more difficult to sort. Two grades are produced with grade one having no bark present and grade two will have small varying amounts of bark present.

The main commercial use for Opoponax is in perfume / cosmetics and aromatherapy / incense but also has medicinal properties for wound care, respiratory congestion, antiseptic / anti-parasitic properties, relief for stomach ailments, menstruation, arthritis, inflammation, and muscle pain.





GUM ARABIC

Gum Arabic is obtained mainly from the Acacia Senegal or Acacia Seyal trees. These trees grow widely across Africa in the Sahelian belt which ranges from Senegal to Somalia south of the Sahara Desert.

This sticky resin oozes from the tree and naturally dries and hardens into nodules that can be picked by hand. These are then sorted according to colour and size but are all Grade one in quality.

Gum Arabic has many uses and applications for food and beverage production as a binder, stabilizer, emulsifier and thickening agent especially for confectionaries (ie candies, icing, fillers, gum etc.) and soft drink syrups. It is widely used in the production of watercolor paints, ceramic glazes, photographic emulsions, lithography processes, charcoal fuels and pyrotechnics.


Export Pricing Terms and Conditions

Below we have summarized our standard terms and conditions for export orders. All specific quotations and supply contracts to be determined according to client requirements at time of order. Please contact us to receive a prompt quotation.

- **All export orders are CIF pricing based upon full container load shipments (except for Essential Oils) (20 ft. container holds approx. 16,000 kg, 40 ft. container holds approx. 28,000 kg.
- Pricing quoted above are for European Destination Ports (contact us for other ports for CIF pricing)
- Bulk shipments packed in 25kg or 50 kg bags according to Buyers requirements. (Special packaging orders could result in extra cost)
- **Essential Oil pricing is FOB Nairobi according to quantity required and orders will be shipped by DHL or other carrier (contact us for volume and destination for exact quotation in regards to shipping costs) -Quotes for Private Labels and custom packaging determined separately according to requirements
